Sir, With due respect I would like to
inform you that while I was returning from
BSMER Hospital Bankura, the above mentioned
truck driver ~~to~~ tried to overtake my Alto K10
while it was standing behind a public bus
near the crossing & the bus also. Because
of opening of the crossing the truck
suddenly stopped & tried to take position
in between my four wheeler & the public
bus. My driver repeatedly given horn
to stop him so that the driver stop
immediately, to avoid any damage/
casualty. But after repeated horn ~~to~~ &
after waving the hand of my driver to
stop, he was still tried to enter in between
my car & the public bus & damaged
my right sided mirror. To avoid further
damage/casualty my driver taken the
car towards more left. After damage
I informed the on duty traffic police
then to the duty officer of that crossing

(Barjora crossing).

The incident happened because of the rash & negligent driving of the driver of Truck no - WB 39 6719.

Please do the needful against the driver so that further this kind incidence would not happened & to improve the road safety.
