Dear Sir,

I Sri Pradip Mandal (Age 41 years), S/o Sri Nalinikanta Mandal, A.E. & Station Manager of Barjora Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date to the effect do hereby lodging complaint against **Sri Samaresh Gord (33 years approx.) S/o Baghambor Gord, Vill –Pingrui, P.O- Maliara, PS- Barjora Dist- Bankura** for committing theft of Electricity dishonestly in his house i.e. domestic premises which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information from secret source today on 06.11.2017 myself along with 1) Sri Bidyut Barn Dey , Jr. Manager. (F&A), S/O. Lt. Kalipada Dey Bankura Division WBSEDCL, 2) Amit Kumar Mandal, Jr. Executive (Finance), S/O. Sri Manik Ch. Mandal , Bankura Division, WBSEDCL, 3) Pijush Prasad S.A.E.(E), S/O. Sri Arjun Prasad and Sumit Chand T.S.H. S/O. Sri Sukumar Chand of Barjora C.C.C. WBSEDCL inspected the domestic Premises of **Sri Samaresh Gord (33 years approx.) S/o Baghambor Gord, Vill –Pingrui, P.O- Maliara, PS- Barjora Dist- Bankura** about 13.20 Hrs. During inspection it was detected that **Sri Samaresh Gord (33 years approx.)** committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL in his domestic premises.

I assessed the connected load as 0.44 KW (4nos Fan 60 watt each, 4nos CFL BULB 20 watt each & 2nos TV 120 watt) and prepared the Inspection report accordingly.

I directed the technical staff (Sumit Chand, T.S.H. BRJ/CCC) to remove the hooking cable i.e. (portion of PVC cable of approx 24ft in length) from LTOH line and accordingly the same was removed.

I seized the hooking cable by Seizure list at spot but the accused person and other local public refused to sign on seizure list. We left the spot at about 13.50 Hrs on 06.11.2017.

The accused person has committed an offence under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are therefore requested to treat this written complain as FIR and take necessary action.
