Dear Sir.

I Sri Pradip Mandal (Age 41 years), S/o Sri Nalinikanta Mandal, A.E. &Station Manager of Barjora Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date to the effect do hereby lodging complaint against Sri Raju Mondal (47 years approx.) (Actual User) S/o, Ramprasad Mondal, Vill – Rajmadhabpur, P.O- Tajpur, PS- Barjora Dist- Bankura for committing theft of Electricity dishonestly in his house I.e. domestic premises which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

On getting information from secret source today on 27.11.2017 myself along with 1) Sri Bidyut Baran Dey, Jr.Manager(F&A), S/O. Lt. Kalipada Dey, Bankura Division, WBSEDCL, 2) Sanatan Gorai, O.E., Tarapada Gorai, Bankura Division, WBSEDCL, 3) Manik Ch. Das, S/O – Lt. Nimai Ch. Das, TSH, Barjora CCC and 4) Sumit Chand T.S.H. S/O. Sri Sukumar Chand of Barjora C.C.C.WBSEDCL inspected the domestic premises of Sri Raju Mondal (47 years approx.) S/o, Ramprasad Mondal, Vill – Rajmadhabpur, P.O- Tajpur, PS- Barjora Dist-Bankura about 12.50 Hrs. During inspection it was detected that the Sri Raju Mondal (47 years approx.), S/O -Ramprasad Mondal committed theft of Electricity dishonestly by means direct hooking from nearby LTOH line

It is mentioned here that one no. electric meter is existing in the premises of Sri Raju Mondal in the name of Ramprasad Mondal (bearing consumer id 232102142) but Sri Raju Mondal was not using electricity from the said meter as he chooses the dishonest path i.e. direct hooking to enjoy the electricity.

I assessed the connected load as 0.647 KW (2 nos. Fridge of 150 Watt each, 3 nos Fan 80 watt each, 3 nos. CFL BULB 9 watt each & 2 nos. Tubelight 40 watt each) and prepared the Inspection report accordingly.

I directed the technical staff (Sumit Chand, T.S.H. BRJ/CCC) to remove the hooking cable i.e. (portion of joined PVC cable of approx 24ft in length with Switchboard & Plug arrangement & Hooking device at one end) from LTOH line and accordingly the same was removed. The existing connection was also disconnected.

I seized the hooking arrangement by Seizure list at spot but the accused person and other local public refused to sign on seizure list. We left the spot at about 13.30 Hrs on 27.11.2017.

The accused person has committed an offence under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are therefore requested to treat this written complain as FIR and take necessary action.
