I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Swapan Kr Bir (user), S/o Lt Kalipada Bir Vill-Amthia, P.O- Brindabanpur, PS- Beliatare Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto-date.

On getting information today 25.11.2017 at about 11:20 AM, I along with 1) Sri Subhadeep Roy, S.A.E(E) 2) Alope Nath Karmakar, Hg Sr L.M 3) Abdul Kashem, L.M 4) Abdul Rahaman Mondal HG TSH 4) Satyapada Roy, Hg TSH 5) Sumanta Danguria, TSH all of them of Beliatare CCC and Sri Biswanath Barui, Sr SAE(E), Sri Sudhir Kr Murmu, Jr Managaer (HR&A) of Bankura (D) Division inspected the domestic Premises of Sri Swapan Kr Bir, S/O- Lt Kalipada Bir, Vill-Amthia, P.O- Brindabanpur, PS- Beliatare Dist- Bankura. During inspection it was detected that Sri Swapan Kr Bir (user), S/o Lt Kalipada Bir, Vill- Amthia, P.O- Brindabanpur, PS- Beliatare Dist- Bankura committed theft of Electricity dishonestly by bypassing the energy meter of existing permanent connection bearing consumer ID 232068905 by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use as a result the energy consumption was not recorded in the energy meter of WBSEDCL. Observed load 1.546 kw (1 no pump, 1 no fridge, 1 no 100w lamp, 5 nos CFL, 4 nos fan, & 1 no tv)

Inspection report was prepared at spot with the signature of accused Sri Swapan Kr Bir(user).

I directed the technical staff to remove the hooking cable from LTOH line and also disconnect the existing permanent service line bearing consumer ID 232068905.

I seized some portion hooking cable, one nos 100 watt lamp, starter of pump and prepare seizure list with the signature of Sri Swapan Kr Bir (Accused) at spot. We left the spot on at 11:50 AM.

It is well proved that the accused Sri Swapan Kr Bir(user), S/O- Lt Kalipada Bir is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
