Dear Sir,

I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Uttam Ghosh, S/o Baren Ghosh Vill-Garibbati, P.O- Jagannathpur, PS- Beliatare Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

On getting information today 20.11.2017 at about 04:20 PM, I along with Sri Chandan Kumar Mondal, D.E & D.M, Sri Rabi Shaw, O.E from Bankura (D) Division and Sri Subhadeep Roy SAE(E), Sri Gangadhar Mondal, ACM of Beliatare CCC inspected the domestic Premises of Sri Uttam Ghosh, S/O- Baren Ghosh, Vill-Garibbati, P.O- Jagannathpur, PS- Beliatare Dist- Bankura.

During inspection it was detected that Uttam Ghosh, S/o Baren Ghosh, Vill- Garibbati, P.O- Beliatare PS- Beliatare Dist- Bankura committed theft of Electricity dishonestly by bypassing the energy meter of existing permanent connection bearing consumer ID 200696313 by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use. As a result the energy consumption was not recorded in the energy meter of WBSEDCL. Observed load 0.4 kw (3 nos 100w lamp, 1 no CFL, 1 no fan)

Inspection report was prepared at spot with the signature of accused Sri Uttam Ghosh. Local people were also asked for signature but they refused.

I directed the technical staff to remove the hooking cable from LTOH line and also disconnect the existing permanent service line bearing consumer ID 200696313.

I seized some portion hooking cable, one nos 100 watt lamp and prepare seizure list with the signature of Uttam Ghosh (Accused) at spot. we left the spot on at 4:50 PM.

It is well proved that the accused Uttam Ghosh, S/O- Baren Ghosh is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
