RJIL is inter alia, engaged in the business of provide all Telecom Services(except GMPCS Services) of non exclusive basis.

On dated 22.10.2017 around 11:00 am when our Technician Mr Bijay Das went to the above mentioned premises for Operation & Maintenance, has noticed that some equipment like Panasonic Battery and door of the Equipment ODC is also opened and this Battery are theft. After that he informed us, and I visit the site and see the Battery was theft.

Therefore we have reasons to believe that some unknown persons with malafide intention illegally and unlawfully had entered our premises and break open the lock forcefully and caused theft to our valuable Materials for their Wrong ful gains, by damaging our Company Property.
