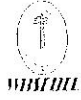

Sub: F.I.R against theft of Electricity.

Sir,

I, Sri Paritosh Kumar Baidya S/O-Lt. Arnulya Kumar Baidya, Station Manager Hirbandh C.C.C, WBSEDCL being authorized under the electricity Act,2003 and electricity (Amendment) Act,2007 do here by lodge complaint against **Rohini Mudi**, S/O. Lt. Purna Mudi address- Vill- Buriam, P.O + P.S- Hirbandh, Dist Bankura for theft of electricity u/s- 135(1)(a) of the electricity Act,2003 and electricity (Amendment) Act,2007 as stated here under :-

That on 15.11.2017 in between 13:50 Hrs. and 14:05 Hrs. myself along with (1) Singri Tudu, S/O. Lt. Sonaram Tudu(Sr. T.S.H.), S&LP Team Bankura RM Office (2) Srijib Sinha (L.M.) S/o Lt Radheshyam Sinha, (3) Ashis Mahato (T.S.H) S/O- Kshudiram Mahato Hirbandh CCC and others inspected the premises of **Rohini Mudi**, with address as noted above on the basis of secret source information.

During inspection and checking **Rohini Mudi** was using electricity unauthorized and dishonestly by direct hooking from nearby LT mains of WBSEDCL for domestic purpose causing and there by huge revenue loss to WBSEDCL. During inspection said Rohini Mudi was not present on the spot but his daughter-in-law (Bharati Mudi, W/O- Sadhucharan Mudi) was present on spot but refused to signed on inspection report and seizure list also.

Thus it is evident that said Rohini Mudi S/O. Lt. Purna Mudi address, Vill- Buriam, P.O + P.S- Hirbandh, Dist Bankura has committed theft of electricity by direct hooking from nearby LT mains of WBSEDCL and liable for prosecution u/s 135(1)(a) of the electricity Act,2003 and Electricity Amended Act 2007.

I prepared the inspection report and assessed the load which came to 0.2 KW on the spot. The unauthorized hooking line was disconnected as per provision of law & I seized the same by preparing seizure list. Local witnesses refused to sign on the inspection report and seizure list. There were other items of electrical appliances which could not be removed and sized at the time of raid. The raiding party left the site at 14:06 Hrs. on same day (15.11.2017) after completion of inspection and checking.

So, you are requested to treat this written complain as FIR, Start a case, arrest the accused and arrange investigation.
