Khatra, Dist - Bankura, 135(i)(a) of the electricity act 2003 amended in 2007 to effect that received an information that Bikash Bauri is committing theft of electricity by direct hooking from LTOH line of WBSEDCL Purpose of running his Poultry Farm.

On getting that information of the theft of electricity today (on 09.11.2017) 2:15 PM to 2:30 PM along with Sri Bijoy Das (AM, FEA), Sri Kanta Das (OE), Shishir Kumar Mishra (T.S.H) & D. Rabul (T.S.H), Havendra Nath Mahata (T.S.H) attached to Khatra Division & Khatra ccc, WBSEDCL inspected the premises of Bikash Bauri and nearby LTOH Line.

During inspection it was detected that above said Person has been committing theft of electricity by direct hooking from nearby LTOH line of WBSEDCL for the purpose of running his poultry Farm. The hooking cable (2 core) was found connected to LTOH line of WBSEDCL.
