I, Sri Kingshuk Bose, s/o - Late Tapas Kumar Bose, Station manager, Khator Customers Care Centre, WBSEDCL, being empowered by electricity act 2003 amended in 2007 do here lodge complaint against Pintu Dhabalbabu, son of Basid Basan Dhabalbabu, vill - Damodaspur, PO - Keshia, PS - Khator, Dist - Bankura, 135(1)(a) of the electricity act 2003 amended in 2007 to effect that received an information that Pintu Dhabalbabu is committing theft of electricity by direct hooking from LTOH line of WBSEDCL purpose of running his poultry farm.

In getting that information of the theft of electricity today (on 14-11-17) 01:00 PM to 01:30 PM along with Sri Souptik Sarkar (AM(HREA), Ramesh Das (OE), Asit Basan Malakar (Sr. Hq. LM), Sisir Kumar Mishra (T.S.H), Md. Rabul (T.S.H) attached to Khator Division & Khator CCL, WBSEDCL inspected the premises of Pintu Dhabalbabu and nearby LTOH line.

During inspection it was detected that above said person has been committing theft of electricity by direct hooking from nearby LTOH line of WBSEDCL for the purpose of running his poultry farm. The hooking hooking cable (2 core) was found connected to LTOH line of WBSEDCL.
