Sub: Lodge F.I.R. against panchanan Mondal, s/o:Late Dasarath Mandal owing to harresment of officer on duty of raid programme against illegal trafficking of minor minerals.

In connection with the above noted subject, this is to inform you that pratik Mondal , Revenue Officer at B.L. & L.R.O., Taldangra was directed by B.L. & L.R.O., Taldangra to launch raid programme against illegal trafficking of minor minerals on 10/11/2017 and the officer accordingly stopped a Tractor on the road from paika to venda under Khalagram Gram Panchayat. But, the owner of the Tractor namely Panchanan Mondal s/o: Late Dasarath Mandal vill. Chhotokurpa P.O.-Ratanpur P.S.-Onda suddenly started hurling abusive language like " ke ADM (LR), ke DM amar naam Panchanan Mondal ai khane apnake ami Bansh dite pari ,SP obdhi amar gari dharar sahos pai na apni ke he, jake khusi bol , tor barite ki maa bon nei ,gari ki ami tor baper takai chalai re," at the officer on duty and pulled the coller of his shirt before threatening him to get run over by the Tractor if he takes any action against him. Again he snatched his phone and threw it away.

In this situation , an F.I.R. must be lodged against the miscreant for safety of the life of the Revenue Officer concerned.
