I hereby lodge complaint against Fajar Ali Khan, S/o-Israfil Khan of Vill-Rajpur, P.S-Taldangra, Dist-Bankura for illegal use of electricity by means of direct hooking, which is an offence u/s 135(1)(a) of Electricity Act 2003, amended in

The incident unfolded as follows:

On 10.11.2017 at around12.45p.m I, along with Sri Abhijeet Layek(OE), Animesh Mondal(LM) under Taldangra CCC went for inspection at the poultry farm premises of Fajar Ali Khan, S/o-Israfil Khan, of Vill-Rajpur P.S-Taldangra, Dist-Bankura on 10.11.2017 at around 1.20 pm in the vehicle bearing Reg No-WB67A3852. On reaching the poultry farm premises of the mentioned user; we found out that, there was a hooking cable directly connected to the nearest LTOH line of WBSEDCL via 2Nos single core PVC cable with hooking device fitted at one end. The cable directly ran up to the poultry farm owned by the user accused. We presumed that it was an illegal connection.

I, immediately directed Sri Animesh Mondal(LM), to disconnect the line, maintaining all safety procedures. He followed my orders accordingly. We seized the cable & prepared seizure list & inspection note on the spot. No user representative agreed to sign the seizure list.

After completing necessary formalities we left the spot in the same vehicle at around 1.45 pm & visited Taldangra Police Station & lodged the complaint.

I would request you to prosecute the user Fajar Ali Khan, S/o-Israfil Khan, of Vill-Rajpur, P.S-Taldangra, Dist-Bankura accused for theft of Electricity which is an offence u/s 135(1)(a) of Electricity Act 2003 amended in 2007. So please treat this complaint as FIR & investigate the same.
