In producing herewith arrested accd. persons namely (1) Satyanarayan Kundu (45) s/o- Lt. Anil Baran of vill- Kenduapur, P.S- Raipur , Dist- Bankura 2) Santosh Hazari (46) S/O- Lt. Gurai of vill-Demushnya ,P.S- Raipur, Dist- Bankura 3) Dhiren Mandi (38) S/O- Lt. Haripada of vill- Maghisole, P.S-Raipur, Dist-Bankura 4) Sanjib Dalal @ Khoka (36) S/O- Lt. Bangshi of vill- Kolmurari, P.S- Barikul, Dist-Bankura and following seized articles i.e 34 numbers of damaged Motorcycles including one government motor cycle, some pieces of broken ad besters, 17 pcs of bamboo sticks, (4) some pieces of stones and (5) 6 nos of Iron rod (as per seizure list attached herewith) and beg to report that ! ASI Dipak Chandra Das, ASI. Somenath Chatterjee, C/776 Tarit Tapadar, C/ 410 Sanatan Soren and C/ 383 Biswajit Adhikary all of Mandaldiha O.P under Barikul P.S vide Mondaldiha OP C.C. No. 2265/17 at. 21.12.17, in course of mobile duty while we reached at Fulkushma Bazar more at about 10.45hrs noticed that above noted accd. sl no 1,2,3 and one Sk. Aakim of vill- Chatridanga , P.S Barikul, Dist-Bankura, Bikash Mandal of Vill- Moulasole, P.S- Barikul, Pintu Chakraborty of Vill-Lurka, P.S- Barikul along with approx 100/150 persons in front of Fulkushma bazaar more . Being asked some of them stated that they were assembled there with a view to organize agitational programme over the incident of assault of Jagannath Gan of Dhau under Barikul P.S. on 20.12.17 evening. As such asked them if there is any prior permission for the programme but they failed to produce any document regarding permission. So I requested them not to organise any programme without permission for the sake of peace in the area. But they disobeyed order of on duty police officer and started moving towards Mandaldiha village and as such I declared them as unruly mob and tried to restrained them but they did not pay heed moreover abused us with filthy languages and all on a sudden they stared damaging TMC party office of Fulkushma Bazar and also started assaulting some party member including one Bultan Sahu. Myself and force tried level best to stop them but to no good as such informed IC Mondaldiha OP as well as IC Barikul PS over telephone for re-enforcement. When we were taking preparation to send the injured Bultan Sahu to the Hospital that time they again started moving towards Fulkushma Bazar more and again they damaged office of I.N.T.T.U.C and again tried to stop them. Then they were assaulted us and threatened with dire consequences and damaged one of our motor cycle bearing No. WB68D/0041 and also assaulted some other TMC party Member and then noticed that above noted accd sl no 4 and one Lalchand Dangar of Vill- Gosda , P.S- Barikul , Tapas Mandal of Raipur . Bikash Ghosh of Pathra P.S-Barikul along with a group consisting 40/50 persons reached Fulkushma Bazar. As such serious chaos started. Both the group started assaulting each other and also damaging several motor cycles in the Fulkusma area. In the meantime IC Barikul PS along with sufficient officer and force reached at the spot and warned them to stop the nuisance but they did not pay heed. As such as per order we started chasing them and applied minimum force to stop the serious breach of peace in the area and then they also started to flee away from the area and after a hot chase arrested the above noted accd. Persons and taken them in to custody after observing all formalities and seized the damaged unclaimed motor cycles as well as some damage articles and offending weapons from the spot. After that we, the injured police personnel treated at Fulkushma Hospital. All the above incident took place in between 10.45 hrs and 15.05 hrs.

Under the above facts and circumstances, I pray that a specific case may kindly be started against (1) Satyanarayan Kundu (45) s/o- Lt. Aakim of vill- Chatridanga, P.S Barikul, Dist- Bankura, 6)Bikash Mandal of Vill- Moulasole, P.S- Barikul, Dist- Bankura 7) Pintu Chakraborty of Vill-Lurka, P.S- Barikul, Dist-Bankura 8) Lalchand Dangar of Vill- Gosda, P.S- Barikul, Dist- Bankura 9)Tapas Mandal of P.S-Raipur, Dist- Bankura 10)Bikash Ghosh of Pathra P.S-Barikul, Dist- Bankura and approx 200 unknown persons under proper section of law for becoming a unruly mob after disobeying the order of an uniform police officer and obstructed police officers to discharge their duty also abused and voluntarily causing hurt as well as used criminal force to deter uniformed police personnel from discharge their duty also damaged govt properties and private properties.
