Dear Sir,

I Sri Pradip Mandal (Age 41 years), S/o Sri Nalinikanta Mandal, A.E. & Station Manager of Barjora Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date to the effect do hereby lodging complaint against **Satyanarayan Mondal (68 years approx.) S/o, Late Nalinikanta mondal, Vill – Harekrishnapur, P.O- Dadhimukha, PS- Beliatore Dist- Bankura** for committing theft of Electricity dishonestly in his house i.e. domestic premises which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information from secret source today on 26.12.2017 myself along with 1) Sri Pijush Prasad, S/O-Sri Arjun Prasad, SAE(E), Barjora CCC, WBSEDCL 2) Sanjoy Lal Singh, S/O – Lt. Laxman Lal Singh, Sr. TSH, Barjora CCC and 3) Asit Kr.Chakraborty, S/O-Lt.Radhagobindo Chakraborty HG.Sr.Linesman Barjora CCC inspected the domestic premises of **Satyanarayan Mondal (68 years approx.) S/o, Late nalinikanta mondal, Vill – Harekrishnapur, P.O Dadhimukha, PS- Beliatore Dist- Bankura** about 11.45 Hrs. During inspection it was detected that the **Satyanarayan Mondal (68 years approx.)**, S/O - **Late Nalinikanta mondal** committed theft of Electricity dishonestly by means of direct hooking from nearby LTOH line of WBSEDCL in his domestic premises.

I assessed the connected load as 0.25 KW (2 nos. bulb 100 watt each, 2nos CFL 20watt each and 1no CFL 10watt) and prepared the Inspection report accordingly.

I directed the technical staff (Sanjoy Lal Singh, Sr. T.S.H., BRJ/CCC) to remove the hooking cable i.e. (portion of PVC cable Aluminum- Single Core of approx 22ft in length with Hooking device at one end) from LTOH line and accordingly the same was removed.

I seized the hooking arrangement by Seizure list at spot, the accused person has signed on seizure list and we left the spot at about 12.05 Hrs on 26.12.2017.

The accused person has committed an offence under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are therefore requested to treat this written complain as FIR and take necessary action.
