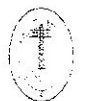

Sub: F.I.R against theft of Electricity.

Sir,

I, Sri Paritosh Kumar Baidya S/O-Lt. Amulya Kumar Baidya, Station Manager Hirbandh C.C.C, WBSSEDCL being authorized under the electricity Act, 2003 and electricity (Amendment) Act, 2007 do hereby lodge complaint against **Sudhir Murmu**, S/O. Lt. Matu Murmu address- Vill- Dhabadi, P.O.- Dighi, P.S- Hirbandh, Dist-Bankura for theft of electricity u/s- 135(1)(b), 135(1)(d) & 135(1)(e) of the electricity Act, 2003 and electricity (Amendment) Act, 2007 as stated here under :-

That on 07.12.2017 in between 13:50 Hrs. and 14:10 Hrs. myself along with (1) Souptik Sarakar (Assistant Manager(HR & A), Khatra Division), S/O- Dilip Kr. Sarkar, (2) Bijoy Das (Assistant Manager(F & A), Khatra Division) S/O Lt. Sudeb Chandra Das, (3) Kartik Chandra Kundu (S.A.E.(E), Hirbandh CCC) S/O- Lt. Sastipada Kundu, (4) Subodh Chandra Patra (Hg. Sr. L.M., Hirbandh CCC), S/O- Lt. Nirmal Chandra Patra and others inspected the premises of **Sudhir Murmu**, with address as noted above on the basis of secret source information.

During inspection and checking **Sudhir Murmu** was using electricity unauthorized and dishonestly by bypassing the meter vide no. P2223586 (Con ID 232099540) through tapping device which connected from incoming phase terminal to outgoing phase terminal for commercial purpose causing interference in accurate or proper registration of actual consumption of the said meter and there by huge revenue loss to WBSSEDCL. During inspection said **Sudhir Murmu** was present on the spot and signed on inspection report and seizure list also.

Thus it is evident that said **Sudhir Murmu** S/O. Lt. Matu Murmu address- Vill- Dhabadi, P.O.- Dighi, P.S- Hirbandh Dist-Bankura has committed theft of electricity by bypassing the meter vide no. P2223586 through tapping device which connected from incoming phase terminal to outgoing phase terminal and liable for prosecution u/s 135(1)(b), 135(1)(d) & 135(1)(e) of the electricity Act, 2003 and Electricity Amended Act 2007.

I prepared the inspection report and assessed the load which came to 1 KW on the spot.

The service line was disconnected as per provision of law & I seized the said meter and service cable by preparing proper seizure list.

Local witnesses refused to sign on the inspection report and seizure list.

There were other items of electrical appliances which could not be removed and sized at the time of raid. The raiding party left the site at 14:11 Hrs. on same day (07.12.2017) after completion of inspection and checking.

It is mentioned here that the said **Sudhir Murmu** made no complaint for ill treatment on spot.

So, you are requested to treat this written complain as FIR, Start a case, arrest the accused and arrange investigation.


