Subject: Physical assault to on duty Excise personnel by some villagers of Sandi & Kuchiara at Kuchiara more Balarampur mouza under leadership of 1. Swarup Roy S/O- Krishnapada Roy, 2. Dhananjoy Roy S/O- Barid Roy.

Sir,

In course of routine patrol duty I along with O.C. Excise Khatra Circle and his staffs went to Lakshmisagar C.S. Shop (newly shifted at Balarampur mouza, Supur G.P.) for an inspection. Verification of the stocks of the shop which had been just started then some local villagers were found gathered in front of the shop throwing filthy words to us. After a few minutes a mob of about 100 villagers assembled there. We came out of the shop to make out what happened. The villagers under leadership of 1. Swarup Roy S/O- Krishnapada Roy, 2. Dhananjoy Roy S/O- Barid Roy started accusing us for opening and lunged over us with Lathis ,Iron rods etc. They furiously attacked over all of our on duty Excise Personnel including me under leadership of the above named persons. They were using abusive and filthy languages. Three Excise Persons including me (Sanjoy Roy & Rinku Mondal both Excise Constables and myself Sri Sankar Prasad Ganguly , Deputy Excise Collector Khatra Range were body assaulted by the miscreants somehow were escaped from there with more or less body injury to all of us. Myself Sri Sankar Prasad Ganguly and Sri Sanjoy Roy, Rinku Mondal both Excise Constables had a treatment at Khatra Sub Divisional Hospital. I was referred to Bankura Medical College & Hospital for a C.T Scan for head injury. (Photocopy of hospital tickets and referral card for C.T. Scan are enclosed)

I would request you to take necessary legal steps against the accused attackers for on duty Excise Personnel and for preventing them from discharging their official duties.

This may be treated as a F.I.R.
