Sir,

In producing herewith one accd. namely Rambabu Choudhury (45) S/o Ramdatt Choudhury of Wariya Mana Dist- West Burdwan to the effect that on 26.12.17 at 10.15 hrs as per order, I along with C/276 Golok Bihari Mahata, C/427 Rabindranath Chakraborty, NVF Sanjib Bhui, VP Dayamoy Das, VP Bidyut Pal, CV Kajal Das, CV Krishna Mondal and 12 others Civic Volunteers vide Mejia P.S CC No- 3314/17 dated- 26.12.17 left for performing anti poppy cultivation campaign over Damodar River Bed area under Mejia P.S.

During performing duty at Jongpur mouza area at about 12.35 hrs huge people gathered at that area. I along with other force asked them about their presence. But they become unruly leaded by Krishna Choudhury and others approx 40-50 in numbers making chaos. All of them were equipped with deadly weapons like lathi, iron rods and bombs. All of them charging crude bombs against police and challenged local administration abusing filthy languages. As a result innocent people of that area were moving here and there with panic.

The entire group was leading by Krishna Choudhury of Wariya Mana with his associates namely Ajoy Choudhury s/o Lt. Acchelal Choudhury, Dipak Choudhury, Pravat Choudhury, Lalmohan Choudhury, Bihari Choudhury, Mahesh Choudhury, Lalan Choudhury, Sikari Choudhury, Jagannath Choudhury all of Wariya Mana and others.

Meanwhile another mobile van leaded by SI Sudarsan Roy and force arrived at the spot and we jointly dispersed the unruly group and maintained peace and tranquility in the locality.

During search at the spot, we found approx 24 lathi, 12 iron rods, huge pieces of bricks and huge chappals and sandals scattered here and there we found several spots where crude bombs were exploded and remnants of the crude bombs were also scattered here and there 02 pieces of live bombs. The whole area was covered with bad smell of burnt explosives we seized the above articles after preparing proper seizure list duly signed by the witness and duly been labeled.

Therefore I pray that specific case in c/w the above noted incident may kindly be started for investigation.
