Sir,

With due respect and humble submission I would like to submit that today; i.e on 05.12.17, to work out an information regarding the illegal construction of wooden Brigde at Bhaglui Ghat by one Baban Chowdhury s/o-Lt. Sitaram Chowdhury of Uttar Palsora, PO- Amritpara, PS- Sonamukhi, Dist-Bankura (Noted in Sonamukhi PS GDE No-206 dated 05.12.17), as per order of OC, Sonamukhi PS I ASI Asoke Nanda along with Const./1138 Arun Chatterjee, Const./715 Sukanta Murmu and NVF 727 Chiranjit Mahapatra left for Bhaglui Ghat under Purba nabasan GP, PS- Sonamukhi , dist- Bankura (Vide Sonamukhi PS GDE no-207 Vide Sonamukhi PS C.C no-2593/17)

On 05.12.17 at about 07:15 hrs when I along with Const./1138 Arun Chatterjee, Const./715 Sukanta Murmu and NVF 727 Chiranjit Mahapatra reach near at Bhaglui Ghat and get down from our govt. Vehicle bearing no- WB 26C 7297 we found some people were engaged to construct the wooden bridge using some wooden logs. I took the photograph of the work from the bank of the Damodar River at Bhaglui Ghat. After that when I along with my force started to proceed towards them, they saw us in uniform and fled away. From the local inquiry it revealed that one Baban Chowdhury s/o-Lt. Sitaram Chowdhury of Uttar Palsora, PO- Amritpara, PS- Sonamukhi, Dist- Bankura has been constructing the wooden bridge which is totally illegal. Previously we also serve a notice mentioning the order of BDO, Sonamukhi that not to construct the wooden bridge as at that time he failed to produce any copy of permission from proper authority.

Thus he has been constructing this wooden bridge illegally disobedience to an order lawfully promulgated by BDO, Sonamukhi, a public servant.

Therefore I pray before your kindness to start a specific case against Baban Chowdhury s/o-Lt. Sitaram Chowdhury of Uttar Palsora, PO- Amritpara, PS- Sonamukhi, Dist- Bankura as per law.

Sub: Attempt to construct illegal temporary, bridge over Damodar River near Bhaglui Ghat under Purbanabasan Gram Panchayat

You are aware that, Sri Baban Choudhury of Vill. Uttar Palsora, the boatman of Bhaglui ferry ghat was trying to construct a temporary wooden bridge to cross the river near Bhaglui Ghat under Purbanabasan Gram Panchayat without any authority & without any permission from the appropriate authority. The undersigned forwarded a complaint on 4.10.2017 submitted by Naresh Choudhury of Vill. Uttar Palsora, the boatman of Bense ferry ghat containing the same information of the illegal construction of temporary bridge. Sri Naresh Choudury again submitted a petition raising several questions against the illegal construction as well as expressing apprehension of loss of his ferry business.

On the other side, Sri Baban Choudhury submitted a prayer for permission to construct the temporary bridge. All the above mentioned applications are enclosed herewith.

Though you have already stopped the said illegal construction of wooden bridge over the Damodar River, yet I am to request you further to keep watch so that no such type of illegal construction is made over the Damodar River as it will be very risky and dangerous from safety point of view as well. So Baban Choudhury has also been informed verbally from this end that no such permission will be granted from this end and no recommendation to construct such dangerous work by him will be made from this end to any appropriate authority.
