I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliature Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Dharmadas Roy, S/o- Amulayaratan Roy, Vill+P.O- Iccharia, PS- Sonamukhi Dist- Bankura. for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today 06.12.2017 at about 02:00 PM, I along with 1) Sri Suranjan Rakshit, AM(F&A), BNKD, 2) Rabi Shaw, O.E., BNKD & 3) Gangadhar Mondal, ACM, BELIATORE CCC 4) Abdul Kashem, L.M, BELIATORE CCC inspected the domestic Primises of Sri Dharmadas Roy, S/o- Amulayaratan Roy, Vill+P.O- Iccharia, PS- Sonamukhi Dist- Bankura.

During inspection it was detected that Sri Dharmadas Roy, S/o- Amulayaratan Roy, Vill+P.O- Iccharia, PS- Sonamukhi Dist- Bankura committed theft of Electricity dishonestly by bypassing the energy meter of existing permanent connection bearing consumer ID 202214171 by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use as a result the energy consumption was not recorded in the energy meter of WBSEDCL. Observed load 0.5 kw (1no water pump, 1 no 100 watt lamp, 1no CFL)

Inspection report was prepared at spot. Accused Sri Dharmadas Roy has signed in inspection report. I directed the technical staff to remove the hooking cable from LTOH line and also disconnect the existing permanent service line bearing consumer ID 202214171.

I seized some portion hooking cable, one nos 100 watt lamp and prepared seizure list signed by the accused & local people.

It is well proved that the accused Sri Dharmadas Roy, S/o- Amulayaratan Roy, Vill+P.O- Iccharia, PS- Sonamukhi Dist- Bankura is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
