I Sri Srideb Saha,S/O- Sidam Saha, S.M Saltora CCC,WBSEDCL, P.S-Saltora, Dist – Bankura, being empowered by the Electricity Act 2003 amended in 2007 do here by lodge complain against accused Kartick Bauri,S/O Lt Binod Bauri of vill-Pirrabaid, Post-Shyampur,Dist- Bankura,P.S- Saltora. We have received an information that the afore said accused person was committing theft of Electricity by hooking device from the nearest L.T.O.H pole of W.B.S.E.D.C.L. for the purpose of Domestic Consumption.

On getting this information on 08.12.2017 between 14:00 hrs to 14:20 hrs, I, along with, Bankura Divisional team and other Technical staffs of Saltora CCC inspect the domestic Premises of Kartick Bauri,S/O Lt Binod Bauri of vill-Pirrabaid, Post-Shyampur,Dist- Bankura,P.S- Saltora..

It was detected that the accused person was committing theft of Electricity by hooking device from the nearest L.T.O.H pole of W.B.S.E.D.C.L. for the purpose of Commercial Consumption to commit the theft of Electricity. I prepared the Inspection report on the spot and the consumption of load was detected as 0.20 KW. Under my direction the Hooking Device was removed.

It is well evident that the accused person has committed an offence u/s 135 (1) (a) at the Electricity Act 2003 amended in 2007.As such, kindly treat this as an F.I.R.
