Dear Sir,

I Sri Pradip Mandal (Age 41 years), S/o Sri Nalinikanta Mandal, A.E. & Station Manager of Barjora Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date to the effect do hereby lodging complaint against **Bhairab Lohar (51 years approx.) S/o, Late Kalipada Lohar, Vill – Gopbandhi, P.O- Dadhimukha, PS- Beliatore Dist- Bankura** for committing theft of Electricity dishonestly in his house i.e. domestic premises to bypass the existing service connection line bearing consumer ID 232227026, which is an offence U/S 135 (1)(a) & (b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

On getting information from secret source today on 08.01.2018 myself along with 1) Sri Pijush Prasad, S/O-Sri Arjun Prasad, SAE(E), Barjora CCC, WBSEDCL and 2) Sanjoy Lal Singh, S/O – Lt. Laxman Lal Singh, Sr. TSH, Barjora CCC inspected the domestic premises of **Bhairab Lohar (51 years approx.) (bearing consumer ID 232227026), S/o, Late Kalipada Lohar, Vill – Gopbandhi, P.O Dadhimukha, PS- Beliatore Dist- Bankura** about 11:15 Hrs. During inspection it was detected that the **Bhairab Lohar (51 years approx.), S/O - Late Kalipada Lohar** committed theft of Electricity dishonestly by means of direct hooking from nearby LTOH line of WBSEDCL in his domestic premises.

I assessed the connected load as 0.41 KW (3 nos. bulb 100 watt each, 1 no. CFL 10 watt, 1 no. Fan 60 Watt and 1no Tube-Light 40 watt) and prepared the Inspection report accordingly.

I directed to the technical staff (Sanjoy Lal Singh, Sr. TSH, Barjora CCC) to disconnect the existing service connection bearing consumer ID 232227026 and also to remove the hooking cable i.e. (portion of PVC cable Copper - Stranded Core of approx 43 ft in length) from LTOH line and accordingly the same was removed.

I seized the hooking arrangement by Seizure list at spot, the accused person refused to signed on seizure list and we left the spot at about 11:35 Hrs on 08.01.2018.

The accused person has committed an offence U/S 135 (1)(a) & (b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are therefore requested to treat this written complain as FIR and take necessary action.
