I. Anup Kumar Mandal S/O-Sri Sahadeb Mandal, Station Manager, Chhatna C.C.C, WBSEDCL being authorized under the electricity Act'2003 and electricity (Amendment) Act'2007 do here by lodge complaint against Joydeb Chitrakar (user) S/O-Lt. Gour Chitrakar address Vill-Bharatpur, P.O-Susunia, P.S-Chhatna, Dist-Bankura for theft of electricity u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007 as stated here under;-

That on 10/01/2018 in between from 15:00 Hrs. to 15:30 Hrs. myself along with (i) Soumen Mondal S/O-Sri Meghnath Mondal, SAE(E), (ii) Md. Selim Khan S/O-Lt. Sayed Khan, Gr-1 TSH, (iii) Jagudas Baisnab S/O-Lt. Bankudas Baisnab, Sr. TSH, (iv) Shaktipada Mahato S/O-Lt. Santosh Mahato, Sr. TSH, (v) Rajesh Majhi S/O-Lt. Dilip Majhi, TSH all of Chhatna C.C.C. WBSEDCL and (i) Amit Kr. Mandal S/O-Sri Manik Ch. Mondal, Jr. Executive (Finance), (ii) Jugal Prasad Kisku S/O-Lt. Gurucharan Kisku, Head Assistant all of Bankura "D" Division WBSEDCL inspected the domestic premises of Joydeb Chitrakar as noted above and found that he was using electricity unauthorizedly and dishonestly by direct hooking from nearby LT mains of WBSEDCL by means of hooking device for their domestic use.

Thus it is evident that said Joydeb Chitrakar (user) S/O-Lt. Gour Chitrakar address Vill-Bharatpur, P.O-Susunia, P.S-Chhatna, Dist-Bankura has committed theft of electricity and liable for prosecution of u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007. During inspection and checking in that said premises Joydeb Chitrakar was not present there.

I prepared the inspection report on the spot and assessed the load which come to 0.10KW. Local witnesses refused to sign in the inspection report.

I directed Md. Selim Khan, Gr-1 TSH to de-hook the wire from nearby LTOH line of WBSEDCL. They de-hooked the hooking wire and I seized 01 (one) item of properties under proper seizure list.

The raiding party left the site at 15:35 Hrs. on same day (10.01.2018) after completion of inspection and checking.

You are therefore requested to please treat this written complain as FIR, start a case, arrest the accused and arrange investigation of this case.
