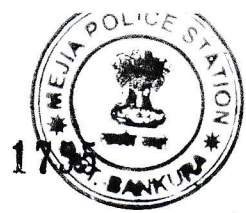

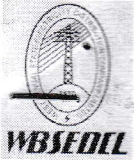

Dear Sir,

I Sri Sandip Das (Age 41 years), S/o Lt. Bhabesh Chandra Das, Sr.S.A.E. & Station Manager of Mejia Customer Care Centre, WBSIEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date to the effect do hereby lodging complaint against **Jayanta Banerjee S/o Rasamoy Banerjee and Subrata Banerjee S/o Rasamoy Banerjee, Vill – Natsala, P.O- Ranipur, PS- Mejia Dist- Bankura** for committing theft of Electricity dishonestly by means of direct hooking from nearby LTOH line of WBSIEDCL in his domestic premises which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information from secret source on dated 29.01.2018 myself along with (i) Kanai Kundu (SAE Mejia CCC), S/o Nimai Kundu (ii) Siddheswar Gorai S/o Santi Gorai (CFO, Mejia CCC)(iii) Santosh Diashi S/o Lt. Anil Diashi (Skilled technician Out source agency)(iv) Sanat Mondal S/o Lt Panchanan Mondal Constable no: 933 Majia P.s (v) Kalyan Bhatteerjee S/o Gour ch. Bhatteerjee NVF, constable No 0122, Mejia P.s and others inspected the domestic Premises of **Jayanta Banerjee S/o Rasamoy Banerjee and Subrata Banerjee S/o Rasamoy Banerjee, Vill – Natsala, P.O- Ranipur, PS- Mejia Dist- Bankura** at about 17.00 Hrs. During inspection it was detected that **Jayanta Banerjee S/o Rasamoy Banerjee and Subrata Banerjee S/o Rasamoy Banerjee, Vill – Natsala, P.O- Ranipur, PS- Mejia Dist- Bankura** committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSIEDCL in his domestic premises though there was one service connection exist bearing consumer Id: 232047835 which was disconnected due to Outstanding dues of Rs 49929.00

I assessed the connected load as 0.6 KW and prepared the Inspection report accordingly.

I directed the technical staff to Physically disconnect the line and remove the hooking cable from LTOH line and accordingly the same was removed.

I seized the portion of hooking cable by preparing Seizure list at spot but the accused person and other local public refused to sign on seizure list. We left the spot at about 17.30 Hrs on 29.01.2018.

The accused person has committed an offence under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are therefore requested to please treat this written complain as FIR, start a case, arrest the accused and arrange investigation of this case.

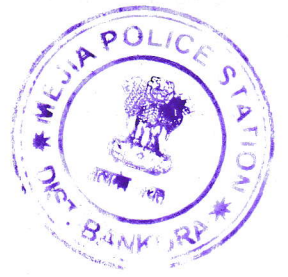
