I Sri Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer  
Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as  
amended upto date do hereby lodge complaint against Sri Sasti Bagdi , S/O Naran Bagdi of Vill –Aralkola (Bagdi  
Para), P.O-Panchal, PS- Sonamukhi Dist- Bankura for committing theft of Electricity dishonestly for his domestic  
purpose which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act,  
2007 as amended upto date .

On getting information today #6.01.2018 at about 02:30 PM, I along with 1) Sri Subhadeep Roy, S.A.E (E) 2)  
Gangadhar Mondal, A.C.M, 3) Sri Alope Nath Karmakar, Hg Sr L.M 4) Abdul Kashem ,L.M, 5) Abdul Rahaman  
Mondal HG TSH, 6) Satyapada Roy, HG TSH 7) Sumanta Danguria, TSH all of them of Beliatare CCC inspected  
the domestic Premises of Sri Sasti Bagdi of Vill –Aralkola (Bagdi Para), P.O-Panchal, PS- Sonamukhi Dist-  
Bankura.

During inspection it was detected that Sri Sasti Bagdi committed theft of Electricity dishonestly by direct hooking  
from nearby LTOH line of WBSEDCL for his Domestic use & observed load 0.12 kw ( 2 nos CFL, 1 no 100watt  
lamp).

It is also found that there was a service connection bearing Con Id:-232236909 which was Disconnected on  
02.02.2015 having OSD amount of Rs 6552.00

Inspection report was prepared at spot. Sasti Bagdi (accused) was asked for his signature but he left the spot  
I directed the Sri Gangadhar Mondal , A.C.M to remove the hooking cable from LTOH line.

I seized some portion of the hooking cable & prepare seizure.

Local villagers were present but they refused to sign.

It is well proved that the accused Sasti Bagdi, S/o Naran Bagdi is liable for prosecution as committed  
theft of electricity under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as  
amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
