1. I earnestly implore you that, I JC-342044X Naib Subedar Arnab Mandal am a resident of village Barjora under your area of jurisdiction and presently serving in the Indian Army in prestigious Bengal Engineer Group as a Junior Commissioned Officer

2. An incident of theft got happened in my house which is located at village Barjora (Mandal Para) during midnight on the day of 15 Nov 2017. Main gate of the house as well as all door of the house was broken including three lockers and everything were smashed in the house. This information was received by me through my relatives on the morning of 16 Nov 2017.

3. Presently, my old age parents are residing with me at my duty station due to their medical treatment. But no one can say, when my parents as well my wife will residing in my house, the same incident may not be happened. Due to exigency of service being a soldier of the Indian Army myself not spared to give safe guard my family. It is very regret to say that family as well as property of a soldier of Indian Army is not safe in your area of jurisdiction. We fight against the enemy of our country in border and sacrifice our life for our motherland but desirous protection/safe guard of our family as well as property is not given by the civil administration.

4. In view of above, your kind consideration in this matter is highly appreciated and investigate the matter and punish the culprit as early as possible so that the same incident may not happened in future.
