Sub: Application for lodge a FIR regarding a street accident.

Respected Sir,

With due respect that I Tarun Bhandari, aged about 30 Years, son of Late Ganesh Bhandari, resident of Flat No: J-11, Sonar Tori, Durgapur- 09, P.S: Durgapur, Dist: Paschim Bardhaman (W.B), most respectfully beg to state that on 02.02.2018 at about 06:30 A.M while my father-in-law namely Balmiki Sharma, aged about 47 Years, son of Pun Dev Sharma, was proceeding towards Bankura by riding a Scooty bearing Regd. No: **WB-40V/9140** through the left side of Barjora-Bankura pitch road, when he reached at Baharakhullya more near Central Bank at that time one Dumper bearing Regd. No: **WB-57C/2550** which was standing prior to the accident at the same place and the driver of the said Dumper suddenly reverse the Dumper with high speed without showing any signal and dashed my father-in-law with his Scooty. As a result he sustained severe bleeding head injury and the Scooty was also badly damaged. With the help of local people he shifted to the Primary Health Centre of Beliatore for treatment where doctor declared him as brought death.

That the accident took place due to rash and negligence with reckless driving and also violation of traffic signal by the part of the driver of Dumper bearing Regd. No: **WB-57C/2550**.

So, Sir, may kindly be pleased to take necessary action against the driver of the said vehicle (Dumper) as per law.
