Dear Sir,

I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatore Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Chandan Bhattacharya S/o Sasticharan Bauri Vill-Purusattampur, P.O- Barkura, PS- Beliatore Dist- Bankura for committing theft of Electricity dishonestly for his Agriculture purpose which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

On getting information today 13.02.2018 at about 12.10 PM, I along with 1) Sri Subhadeep Roy, S.A.E(E) 2) Gangadhar Mondal, A.C.M 3) Ganesh Das, Supervisor all from Beliatore CCC inspected the STW premises (paddy field) of Sri Bhairab Bauri, S/O- Sasticharan Bauri at Vill-Purusattampur, P.O- Barkura, PS- Beliatore Dist- Bankura, During inspection it was detected that Sri Bhairab Bauri, S/O- Sasticharan Bauri committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL for his Cultivation. For which WBSEDCL loss huge revenue. Detected load 2 HP (1.492 Kw) was. Inspection report was prepared on spot. Accused Sri Bhairab Bauri was for his signature but he refused. I directed the technical staff to remove the hooking cable from LTOH line. I seized some portion hooking cable with hooking device. we left the spot on at 12.30 PM.

It is well proved that the accused Sri Bhairab Bauri, S/O- Sasticharan Bauri is liable for prosecution as committed theft of electricity by direct Hooking under Section 135 (1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain, treat this letter as F.I.R to start a case for further investigation to arrest the accused to stop such revenue loss of WBSEDCL
