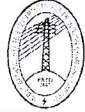

Dear Sir,

I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Chandan Bhattacharya S/o Himangsu Bhattacharya Vill-Purusattampur, P.O- Barkura, PS- Beliatare Dist- Bankura for committing theft of Electricity dishonestly for his Commercial purpose which is an offence under Section 135(1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today 13.02.2018 at about 12.40 PM, I along with 1) Sri Subhadeep Roy, S.A.E(E) 2) Gangadhar Mondal, A.C.M 3) Ganesh Das, Supervisor all from Beliatare CCC inspected the domestic Premises of Sri Chandan Bhattacharya, S/O- Himangsu Bhattacharya at Vill-Purusattampur, P.O- Barkura, PS- Beliatare Dist- Bankura, During inspection it was detected that Sri Chandan Bhattacharya, S/O- Himangsu Bhattacharya committed theft of Electricity dishonestly by bypassing the energy meter of existing permanent connection bearing consumer ID 232121365 by direct hooking from nearby LTOH line of WBSEDCL for his Commercial use as a result the energy consumption was not recorded in the energy meter of WBSEDCL for which WBSEDCL loss huge revenue. Observed load 2.0 kw. Inspection report was prepared at spot. Accused Sri Chandan Bhattacharya was for his signature but he refused. I directed the technical staff to remove the hooking cable from LTOH line and also disconnect the existing permanent service line bearing consumer ID 232121365. I seized some portion hooking cable. we left the spot on at 01:00 PM.

It is well proved that the accused Sri Chandan bhattacharya, S/O- Himangsu Bhattacharya is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain, treat this letter as F.I.R to start a case for further investigation to arrest the accused to stop such revenue loss of WBSEDCL
