It was detected that the accused person was committing theft of Electricity by hooking device from the nearest L.T.O.H pole of W.B.S.E.D.C.L. for the purpose of Domestic Consumption to commit the theft of Electricity.

I prepared the Inspection report on the spot and the consumption of load was detected as 0.25 k.w. Under my direction the Hooking Device was removed.

It is well evident that the accused person has committed an offence u/s 135 (1) (a) at the Electricity Act 2003 amended in 2007.
