Respected Sir,

In producing herewith following accused persons namely 1.Tinku Ghosh (34yrs), S/O-Lt. Anadi Ghosh of Maruibazar 2.Basudeb Halder(53yrs), S/O-Tarinikanta Halder of Dalmadal Road, near Chinnamasta Temple 3.Tanmoy Dey(31yrs), S/O-Shaymapada Dey of Katandhar 4.Suvendu Sil(35yrs), S/O-Lt. Sadhan Sil of Katandhar all of PO+PS-Bishnupur, Dist-Bankura alongwith seized articles Viz. Cash Rs.32,236/- and other gambling articles, I would like to draw your kind attention to the fact that received information from secret source at 15.55hrs vide Bishnupur PS GDE no-1304, that few persons got assembled in an abandoned house, back side of Bishnupur Treasuary , near Bishnupur PWD office, under PS-Bishnupur, Dist-Bankura for the purpose of gambling. As such, I informed the matter to IC, Bishnupur PS and as per his kind instruction myself along with force left my location at 15.55hrs vide Bishnupur PS Special CC No-23/18, Dt-24.04.18 for aforesaid place for executing the source information.

Arrived at the PO at 16.15hrs, Cordoned off the house and found aforesaid accused persons were engaged in gambling for wrongful gain and wrongful loss . Seeing the police jeep Some of them managed to escape away but the above noted persons were detained and restrained by us. I seized Cash Rs.32,235/- from the gambling board as board money, three (03) Set of playing cards and two(02) plastic mats from the PO, in between 16.35hrs to17.35hrs as per seizure list in front of my accompanying forces and took their signature in the seizure list as onlookers refused to sign in seizure list. In between 17.35hrs to 17.55hrs I arrested the above noted accused persons after observing all legal formalities.

Now, I pry to your good self that a case under section 3&4 WBG&PC Act may kindly be started against the aforesaid accused persons.
