Sir,

In producing herewith two arrested persons namely Smt. Chaina Ghosh (41 yrs) W/O-Sadhan Ghosh and Gayatri Ghosh (48y) W/O- Pagal Ghosh both of Village:-Bhalukapahari, PS- Beliatore, Dist:- Bankura, I beg to report that today on 13.05.2018 at about 04:15 hrs I SI Srimanta Chakraborty along with C/1737 Srikanta Mandal, C/1455 Sk Maniruddin, LC/816 Kobita Mandi, LC/1371 Sumanta Singha, and others forces went to the village Bhalukapahari under Beliatore PS for investigation and to hold raid in c/w Beliatore PS Case No:- 41/18 dt:- 06.12.2018 U/S- 147/149/324/506 IPC & 3/4 E.S. Act, When we arrived in the said village and held raid in the house of accd Gouranga Ghosh S/O-Pagal Ghosh, 10-11 ladies along with some other persons suddenly surrounded us and thrown abusive languages , targeting with a view to obstruct the Police personnel to discharge Government duty. We tried to stop them but then they become more aggressive and threw lump of stone, brickbat etc targeting to us and continuously they obstructed us to investigate and to held raid in the houses of FIR named accd persons. During such incident few of us police personal including me got injuries. After that again and again we asked them not to restrained police personal to discharge the duty of police but they ignored. After that seeing no alternative I declared them arrest, on that time few persons fled away and finally able to arrest two ladies namely Smt. Chaina Ghosh (41 yrs) W/O- Sadhan Ghosh and Gayatri Ghosh (48y) W/O- Pagal Ghosh both of Village:-Bhalukapahari, PS- Beliatore, Dist:- Bankura with the help of lady police personal, after maintaining all formalities of arrest and guide line of NHRC.

Therefore I request you that kindly take necessary legal action against the above

mentioned accd persons.
