Sir,
I, MD Afroz Ahmad, Assistant Engineer & Station manager of Indpur CCC, PO+PS: Indpur, Dist: Bankura do hereby lodge a complaint against Koushik Dutta (User), S/O Purnendu Dutta of Village: Boga, PO: Boga, PS: Indpur, Dist.: Bankura, for committing theft of Electricity by Direct Hooking from nearest L.T.O.H. line at his commercial premises.

On today i.e. 21.05.2018 at about 13:20 hrs myself along with 1) Saroj Kumar Biswas (LM –Indpur CCC), 2) Singrai Tudu (Sr. TSH- S&LP Bankura Regional Office), and others left for village Boga for holding raid following a source information.

We reached village Boga at 13:40 hrs and came to the house of Koushik Dutta (User), observed & found that Koushik Dutta (User) was enjoining electricity unauthorized by direct hooking from nearest LTOH line for commercial use in his premises. So, his illegal service line was disconnected.

I prepared the inspection report and seized the articles in presence of witness 1) Saroj Kumar Biswas (LM – Indpur CCC), 2) Singrai Tudu (Sr. TSH- S&LP Bankura Regional Office), under proper seizure list, stated in separate seizure list. Koushik Dutta (User) was not present when following item was seized. Local people was present but not appeared to sign.

We seized the articles (Sample basis) of two core flexible cable of length about 7 meters (approx) with hooking arrangement. Our team left the site at about 14:00 hrs. So Koushik Dutta (User), has committed theft of Electricity in his house by direct hooking from nearest LTOH line and liable for prosecution u/s 135(1) (a) of Electricity Act 2003, and with amendment Electricity Act 2007.

Kindly treat this Complaint as FIR and take necessary action.
