I,Sri Birugopal Bhattacharya , son of Sri Ramamrita Bhattacharya of Baramile , Beliatore , P.S. Beliatore, Dist. Bankura lodge this complaint to the effect that ,I am a reputed businessman of Beliatore. I have been running the business for long time. I used to deal in cement, rod etc. The accused Swapan Mal purchased some cement and rod from my shop on credit. He has constructed a building at Beliatore and rented a portion to State Bank of India . However, during the construction of the building a considerable amount of cement and rod was taken by the accused from my shop on credit. The accused assured me that he would clear the entire payment to me and on his such assurance I have supplied the required goods to the accused from time to time. When the construction work was completed I submitted my bill to the accused in respect of %.1,32,161/-(One lakh thirty two thousand one hundred sixty one) only requested him to make the payment .On receiving the bill the accused assured me to make the payment within a short time but it is a matter of regret that in spite of my repeated approache

Officer-in-charge BELIATORE POLICE STATION the accused has failed to make the payment to me delibera-DIST. BANKURA (W.B.) tely . The accused is a moneyed man and he has sufficient ability to make the payment to me at any moment.

On 19.3.2018 I met the accused in front of State Bank of India ,Beliatore Branch and gently requested him to make the arrangement of making my payment early as my business is being affected for his non payment . On such request the accused became furious and started abusing me in filthy languages and a: all on a sudden he put off his shoe from his leg and began to assault me left and right. I became perplexed by the conduct of the accused. At that time some persons who were there, they came on rescue me. Two of such persons are known to me and their names are 1.Sri Prasanta Das Modak , son of Chandrasekhar

Das Modak of Radhabazar Beliatore and 2) Sri Ganesh Dutta, son of Dharanidhar Dutta of Fulberia P.S.Beliatore, Dist.Bankura The accused threatened me by saying that he would not pay the money to me, he also told me that I may do whatever I like. I realised that in order to cheat me the accused has taken the goods from my shop on credit.

I being a reputed man of the area, have been highly humiliated -d by the inhuman conduct on the part of the accused.

I therefore humbly request you to take suitable measures by initiating a criminal proceeding against the accused for cheating and assault caused by the accused.
