Son of late Guseep Singh Resident of Kojma Jambhedpur-831005. P.S-Kojma
Dist-Singbhum (J.H), Most respectfully beg to state that on 4/6/18 at about
4:30 A.M while my Driver Name Anil Singh Aged about 25 years old was
proceeding towards Jambhedpur by Empty Trailer bearing Regd. No-NL02Q-5585
through the left side of Durgapur Bankura Road (SH-9) when he reached
at beliatore. This incident I hear with telephone with unknown number.
When he reached at beliatore near JODA HOTEL at that time one lorry
bearing Regd. No-WB67B-1352, which was coming from Bankura with
high speed & wrong side lorry coming without showing any signal
and hit my Trailer No-NL02Q-5585 with Driver Name Mr. Anil Singh
As a result he sustained severe bleeding body injury and the
Trailer was also badly damaged. With the help of local people he shifted
to the Bankura Hospital for treatment & expense here.

The accident took place due to rash and negligence with recklessness
driving and also violation of traffic signal by the path of the
driver of lorry bearing Regd. No-WB67B-1352.

So, Sir May kindly be pleased to take necessary action against
the driver of the said vehicle (lorry) as per law.
