I prepared inspection report on the spot and assessed the consumption of load  
which was detected as 0.5KW.

I instructed Sri Amit Dhibar, L.M ,Onda CCC to dehook the hooking device and  
to disconnect the illegal connection mentioned above from the LTOH line of  
WBSEDCL and accordingly he did the same. Then I seized the hooking cable
