Dear Sir,

I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against **Sri Chandi Roy(User), S/o Rantu Roy Vill-Dangchoulia, P.O- Majirdanga, PS- Beliatare Dist- Bankura** for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today 06.07.2018 at about 01:00 PM, I along with 1) Sri Subhadeep Roy, S.A.E(E) 2) Gangadhar Mondal, A.C.M 3) Abdul Kashem, A.C.M 4) Abdul Rahaman Mondal HG TSH 4) Satyapada Roy, Hg TSH 5) Sumanta Danguria, TSH 6) Yuddhapati Das, Hg TSH, all of them of Beliatare CCC and Sri Suranjan Rakshit, A.M (F&A), Sri Malay Das, Sr T.S.H of Bankura (D) Division inspected the domestic Premises of **Sri Chandi Roy, S/o Rantu Roy Vill-Dangchoulia, P.O- Majirdanga, PS- Beliatare Dist- Bankura**. During inspection it was detected that Sri Chandi Roy committed theft of Electricity dishonestly by bypassing the energy meter of existing permanent connection bearing consumer ID 232149657 by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use as a result the energy consumption was not recorded in the energy meter of WBSEDCL. Observed load 0.5 kw (1 no 100w lamp, 3 nos fan, 1 nos CFL & 1 no tv)

Inspection report was prepared at spot with but the accused and local public refused to sign.

I directed the technical staff to remove the hooking cable from LTOH line and also disconnect the existing permanent service line bearing consumer ID 232149657.

I seized some portion hooking cable, one nos 100 watt lamp and prepare seizure list. Accused refused to sign. we left the spot on at 1.20PM.

It is well proved that the accused Sri Chandi Roy (user), S/O- Lt Rantu Roy is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R to start a case for further investigation to arrest the accused to stop such revenue loss of WBSEDCL.
