

Dear Sir,

I Sri Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date to the effect do hereby lodge complaint against Smt Mukta Ghosh (User), w/o- Swapn Ghosh Vill-Muktapur, P.O- Barkura, PS- Beliatare Dist- Bankura for committing theft of Electricity dishonestly for his Domestic purpose which is an offence under Section 135(1)(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today on 24.08.2018 at about 02:00 PM, I along with 1) Sri Subhadeep Roy , S.A.E, 2) Abdul Rahaman Mondal HG TSH 3) Satyapada Roy, Hg TSH 4) Sumanta Danguria T.S.H all of Beliatare CCC , WBSEDCL inspected the Domestic Premises having Consumer ID 232170163 of Smt Mukta Ghosh (User), w/o- Swapn Ghosh Vill – Muktapur, P.O- Barkura, PS- Beliatare. During inspection it was detected that the accused committed theft of Electricity dishonestly by tapping the incoming service cable (before meter) bypassing the existing installed meter bearing No B3902059 as a result energy consumption was not recorded in the energy meter of WBSEDCL, for which WBSEDCL loss huge revenue. Detected load 0.986 K.W

Inspection report was prepared at spot with the signature of the consumer (accused) and other local public were asked for their signature on inspection report but they refused to sign.

I directed the technical staff to disconnect the service line from pole and they accordingly disconnect the same. I seized the tapping wire, and one 100 watt lamp and prepare seizure list at spot with the signature of accused. local public refused to sign on seizure list.

Copy of inspection report and seizure was hands over to the accused and we left the spot at about 2:40 P.M.

The accused person has committed an offence under Section 135 (1) (b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain, treat this letter as F.I.R to start a case for further investigation to arrest the accused to stop such revenue loss of WBSEDCL
