During inspection it was detected that above said person has been committing theft of electricity by direct hooking from nearby LTOH ^{line} of WBSEDCL for the purpose of charging his Tata T-67/B15-0001. The hooking cable (1 core) was found connected to LTOH line of WBSEDCL.

I prepare inspection report on the spot assessed the consumption of load as 0.2 KW.

I directed Sri Asit Baran Malakar, H.Q. Sr. LM to de-hook the hooking cable and accordingly he has de-hooked the cable, which have been seized.

It is well evident that Sri Nihar Chandra Das has been committing theft of electricity by electricity hooking from nearby LTOH line of WBSEDCL. As such he is liable for prosecution U/s 135 (1) (a) of electricity act 2003 amended on 2007.

The copy of seized list and inspection report could not be supplied to accused person or his representative due to non-availability in the spot.
