Dear Sir,

I, Sri Goutam Kala, S/O- Lt. Sudhir Chandra Kala ; AE & Station Manager, Raipur CCC, WBSEDCL, Dist-Bankura do hereby lodge complaint against accused **Krishna Mandal, S/O- Kalipada Mandal, Vill-Chorkol, P.O.-Dheko, P.S.-Raipur, Dist-Bankura** to the effect that received secret information, the aforesaid accused person was committing theft of electricity by direct hooking from nearby LTOH line of WBSEDCL for the **Commercial purpose**.

On getting this information on 23.08.2018 between 12.35 hrs to 12.55 hrs, I along with Sri Prasenjit Mandal, S.A.E(E) and Manoranjan Hazari, L.M., all are Raipur CCC, WBSEDCL, inspected the Commercial premises at **Chorkol More** of accused **Krishna Mandal, S/O- Kalipada Mandal, Vill-Chorkol, P.O.-Dheko, P.S.-Raipur, Dist-Bankura**. During inspection it was detected that said accused person was using electricity for the his **Commercial shop** by direct hooking from nearby LTOH line of WBSEDCL.

Consumption load which was detected as 0.35 KW by inspection team. Accordingly inspection report was prepared. Villagers were present but refused to sign in inspection report.

I directed Sri Manoranjan Hazari, L.M, Raipur CCC to de-hook the hooking cable from LTOH line of WBSEDCL and he did the same which I seized 02 nos single core PVC cable approx length 20 feet each as a sample basis after preparing seizure list.

It is well evident that the accused person was committing theft of electricity by direct hooking from nearby LTOH line of WBSEDCL as such he is liable for prosecution u/s 135(1)(a) of Electricity Act 2003, Amendment in 2007.

Kindly treat this complaint as F.I.R.
