Dear Sir,

I Sri Pradip Mandal (Age 42 years), S/o Sri Nalinikanta Mandal, A.E. & Station Manager of Barjora Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date to the effect do hereby lodging complaint against Milan Sk. (27 years approx.) (Actual User) S/o, Late Jiad Ali Sk., Vill – Pakhanna (Natungram), P.O- Pakhanna, PS- Barjora Dist- Bankura for committing theft of Electricity dishonestly in his house i.e. domestic premises which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information from secret source today on 12/10/2018 myself along with 1) Sovan Das, S/O- Sri Anil Kr Das, SAE(E), Barjora CCC, 2) Manik Ch. Das, S/O – Lt. Nimai Ch. Das, Sr. TSH, Barjora CCC, 3) Sumit Chand T.S.H. S/O. Sri Sukumar Chand Barjora C.C.C. and 4) Dilip Kr. Saha, S/O- Late Gour Ch. Saha, SE(E) , 5) Debdas Chatterjee, S/O- Late Gurudas Chatterjee, S.O. & 6) Debashis Pal, S/O- Trijoy Pal, SAE(E) of the Corp. S&LP, Vidyut Bhavan and 7) Surjeswar Sen, S/O- Late Guruprasad Sen, SE(E) & 8) Sitaram Banerjee, S/O- Niranjan Banerjee, S.O of the S&LP wings of Bankura Region, WBSEDCL inspected the domestic premises of Late Jiad Ali Sk. at Pakhanna (Natungram) at about 14:15 hrs and it was detected that there is one existing meter having no. DDG286579 against consumer ID 232080439 in the name of Late Jiad Ali Sk. at Pakhanna (Natungram) but the line was disconnected from LT line due to nonpayment of energy bill. His son Milan Sk. (27 years approx.) who is the actual user was using electricity unauthrizedly by means of direct hooking from LT line at that disconnected premises. Theft was detected.

I assessed the connected load as 0.20 KW (2 nos Fan 60 watt each, 2 nos. CFL BULB 10 watt each & 1 no. bulb 60 watt each) and prepared the Inspection report accordingly and that was refused to be signed by the accused.

I directed the technical staff (Sumit Chand T.S.H. BRJ/CCC) to remove the hooking cable fitted with hooking device. Accordingly the same was removed.

I seized the said articles by Seizure list at spot and it was refused to be signed by the accused person. We left the spot at about 14:35 Hrs on 12/10/2018.

The accused person has committed an offence under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are therefore requested to treat this written complain as FIR and take necessary action.


