In producing herewith the following arrested accused namely 1) 1) Sk Sajjad @ Sajjad (25) S/O late Durlav Sekh of Dwarika PS Bishnupur 2) Sk Fatik (27) S/O Rakub Sekh of Do 3) sk Ajimal @ Modhu(32) S/O Sk Anis of Do 4) Ismail@ Sk Ismail (36) S/O sk Akbar of Do 5) Sk Mobarak(32) S/O late Sk Sattar of Do 6) Sk Islam (34) S/O Ainur of Do all under Bishnupur PS with following seized items -1) 04 (Four) Pieces of Live bombs kept in a black poly pack 2) one sharp dagger having wooden handle and length of two feet 3) one sharp Vojali having wooden handle having length of 18 inches approx 4) one iron rod having length of 3 feet 5) one iron rod having length of 3 feet and 6 inches 6) one black polybag containing 02 (two) live bombs 7) one bottle (half finished) of whisky of officer choice brand 8) eleven polythene glass emitting the odour of alcohol 9) 4 packets of Gutka and do here by lodge a complaint as suo motu against said arrested accused and 5/6 unknown others to the effect that on 13/10/18 evening at about 1930 hrs while holding pre puja drive with IC Bishnupur Sri Astik Mukherjee and force (vide Bishnupur PS GD 711 dt 13/10/11 and CC No 4924/18), at Dwarika Bus stand a source on condition anonymity acme and informed that said arrested accused along with 5/6 unknown others being armed with bombs, sharp weapons, and other deadly weapons assembling at one open place near Basabi Steel factory which is located just opposite direction of Rajesh Hotel at Dwarika under Bishnupur PS, taking preparation to commit dacoity . I tried to convince local people to accompany us but none became willing to accompany us and to be witnesses. Accordingly myself with IC and accompanying force and source left for the above place of assembly of the miscreants and at 1950 hours reached near the place and stealthily cordoned the assembly of said miscreants and found they were talking in low tone and we heard about their plan to commit dacoty in the house of Harun Al Rashid S/O Lt Sk Lokman of Dwarika who is an affluent businessman and at 1955 hrs we challenged the miscreants and realizing the presence of police they started taking to their heels but somehow chasing after them desperately we managed to detain them ( as named above) remaining 5/6 escaped. We introduced ourselves as police men with the help of torch light and asked them to search our persons but they declined. Accordingly searching their persons from 2000 hrs to 2030 hrs abovenoted black polythene bag containing four live bombs were found in the possession of above Ismail@ Sk Ismail, two bombs kept in black

polythene bag was found with above Sk sajjad, , the sharp dagger having wooden handle was found from the possession of Above Sk Ajimal, the vojali was found in the possession of Sk Mobarak, the iron rod having length of 3 feet was found with above Sk Fatik, and another iron rod as noted above was found with Sk Islam, Besides the aforesaid items, the bottle of whisky, the aforesaid polythene glasses, the Gutka packets were found lying at above place of assembly. From 2040 hrs to 2100 I seized above items under a memo of seizure duly attested by police witnesses as no member of public could be found to attest the seizure list as witnesses. The seized items were properly labeled with the attestation of seizure witnesses and accused persons. On being asked they admitted that they assembled there with bombs etc to prepare themselves for committing dacoty in the house of Harun Al Rashid of Dwarika (as above), the persons those who escaped were also their associates. Accordingly from 2120 to 2150 hrs arrested them preparing memo of arrest. Informed their relatives as to their arrest. Conveyed the ground of arrest to them by issuing memo of arrest to them.

The act of the accused is liable u/s 399/402 IPC R/W  $\frac{3}{4}$  Explosive substance act . Hence I lodge the FIR as suo motu against the arrested accused and the escapees u/s 399/402 IPC R/W 3/4 Explosive substance act
