I am Namrata Majumdar, D/o-Swapan Kumar Majumdar, resident at Malanchapara, wardno.-3, P.O+P.S-Bishnupur, Dist-Bankura, beg to state you that on 16/10/2018 I have come to know from my ex-student Surodip Ghosh, student of BPIE, mechanical 3rd year, s/o-Lalmohan Ghosh, resident at Kanchanguri Kowra, P.S-Garbata, Dist-Paschim Medinipur, whose room no.-305, guardian no.-8945985993, that few electronic messages, obscene languages, obscene pictures, videos of mine and addressing me that is found from five fake Facebook accounts which are fake namely-1)Koushani Chatterjee, 2)Nilanjana Chatterjee, 3)Sushmita Chatterjee, 4)Vhisal Sengupta and 5)Mr. X"xmr1996@yahoo.com on different dates. The accused persons behind all of the above posts in the above fake accounts are Kushal Mallick alias Titu, s/o- Ujjal Mallick resident at Hazrapara near Kalimandir, P.O+P.S- Bishnupur, Dist-Bankura, who is presently residing Antop Hill Church Colony, Antop Hill Church Naka, Mumbai, Maharashtra, 400037, who is mainly involved with all the obscene posts through the above named five fake accounts, found one vaginal picture on 18/08/2018 and other comments unparliamentary in nature and character directly and indirectly addressing me there in, private pictures, manufactured and so on prior to that dated from 16/06/2018 onwards. It is also fact two more person namely Abhishek Goswami alias Prem and Souvagya Goswami whose mobile no is 8409667037 are guilty associates of prime accused Kushal Mallick alias Titu, who helped Kushal Mallick in the opening of fake facebook accounts. I know each and everyone. These persons are also efficient hackers. Accused Kushal Mallick alias Titu is also accused of posting naked, obscene pictures of other girls prior to the sending, posting and circulating my pictures, videos, obscene languages addressing me through fake accounts. Kushal Mallick alias Titu is taking revenge with me due to the splitting of relationship. So It is requested to you to take necessary legal action against accused Kushal Mallick alias Titu for posting, circulating, sending obscene pictures, manufactured pictures, videos, addressing filthy, unparliamentary languages to me and of mine in the social media to malign me and other conspirators Abhishek Goswami alias Prem and Souvagya Goswami for helping him and it is also requested to take necessary steps to stop further circulation such obscenity of mine through social media and so on. I took these days in collecting the evidence in support of my complaints.
