Dear Sir,

This is to inform you that last night on 26.09.2018 at about 01.10 AM 11 KV local feeder found to be broken down, then I received a call from our staff that i.e. L.T. & H.T. line 03 nos pole had been broken by the vehicle, bearing no.- WB-67B-5553. As communication local people and our staff u/s came to know the vehicle (WB-67B-5553) owned by Sri Monikanchan Das C/O-Sri Styakinkar Das, Gobindapur, P.O-Bankura.

During this period the power of the 11 KVOH Indpur local feeder was completely defunctionable causes interruption of power to the nearby areas & Hospitals etc. The mostly effected village is Nuniabad which is exactly accident site where we are trying to restore power on urgent basis by replacing those broken poles of HT & LT line.

As aforesaid incident which may results into electrical accident and unsafe condition, was taken place due to the vehicle bearing no-WB67B-5553, the driver of the vehicle solely responsible of for that incident. As per WBSEDCL norms he is required to pay/deposit the estimated amount for the rectification of the said breakdown work towards restoring the power.

So, you are hereby requested to kindly take the necessary action and also to treat this intimation as a FIR for recovery of estimated amount as per WBSEDCL norms.
