Sir,

I do here by lodge written complaint against - 1) Dhaneswar Tudu, S/O - Lt. Suklal Tudu of Vill - Rajakata(Simuldanga), (Ranibandh Block President of Bharat Jakat Majhi Paragana Mahal), 2) Saharai Saren, S/O - Jaleswar Saren of Vill - Rajakata (Kheriasai), 3) Dukhi Mudi, W/O - Indra Mudi, of Vill - Talgora, 4) Gosthabihari Majhi, S/O - Lt. Bahadur Majhi of Vill - Tantiberia, 5) Ranjit Hansda, S/O - Lt. Gopinath Hansda, of Vill - Hakimsinan, 6) Raghunath Hembram, S/O - Sushil Hembram of Vill - Keliapathar (Rakhaghutu) all under P.S - Ranibandh, Dist - Bankura and 150/200 other unknown persons as suo-moto to the effect that on getting RTM information from DIB, Bankura vide Memo. No. 7752/DIB Dated -23.09.18. that Bharat Jakat Majhi Paragana Mahal has called indefinite Rail, Road Blockade programme all over West Bengal including Ranibandh Talgora, under Ranibandh P.S on their various demands. As per order of superiors, I Inspector Uttam Kr. Debnath, I/C Ranibandh P.S. along with ASI Jakir Ansari, ASI Nandalal Mandal along with C/888 Amit Bouri, C/132 Swapan Kr. Majhi, LC/1762 Aloka Hembram left for Talgora More to perform L/O duty so that no untoward incident occur and to ensure normal flow of traffic. This refers Ranibandh P.S GDE No. 770 and GDE No. 774 both Dt. 24.09.18. Having reached at Talgora More at around 07.45 hrs, I found that approx 150/200 unknown persons under the leadership of 1) Dhaneswar Tudu, S/O - Lt. Suklal Tudu of Vill - Rajakata(Simuldanga), (Ranibandh Block President of Bharat Jakat Majhi Paragana Mahal), 2) Saharai Saren, S/O - Jaleswar Saren of Vill - Rajakata (Kheriasai), 3) Dukhi Mudi, W/O - Indra Mudi, of Vill - Talgora, 4) Gosthabihari Majhi, S/O -Lt. Bahadur Majhi of Vill - Tantiberia, 5) Ranjit Hansda, S/O - Lt. Gopinath Hansda, of Vill -Hakimsinan, 6) Raghunath Hembram, S/O - Sushil Hembram of Vill - Keliapathar (Rakhaghutu) all under P.S - Ranibandh, Dist - Bankura and 150/200 other unknown persons have gathered on SH - 02 (Bankura to Jhilimili Road) at Talgora More with placard of "Bharat Jakat Majhi Paragana Mahal" and they blockade the SH - 02. They have lathi, ballam, Tangi, arrows and bows and illegal arms with them. On seeing the Police, they were shouting slogans in favour of their demands. I approached to them and requested them to remove the road blockade and to allow normal movement of traffic. But the accused persons did not pay any

heed to me and continued to block the road. Consequently, a huge number of vehicles got struck on the SH-02. Then, I announced their gathering as unlawful assembly and requested them to disperse instantly. But they continued to block the SH – 02 and disobeyed my order. Having found no other alternative, I along with other officers and force tried to remove the unlawful assembly from SH – 02 for smooth movement of vehicle but the miscreants obstructed us to discharge our official Govt. duty. The passengers of public vehicle and drivers and passengers of other vehicle and other drivers of goods carriage requested the miscreants to allow them to pass but the above noted miscreants threatened them with dire consequences. Throughout the day, we tried to remove the blockade and reinforcement was made in this regard. At last on 24.09.2018 at 18.15 hrs. we succeeded to remove the road blockade from SH – 02 at Talgora More.

Thus the above noted miscreants have committed offence U/S - 143/144/145 /147/148/149/186/341/342/353/506/120B IPC and 27 Arms Act. Λ specific case against 1) Dhaneswar Tudu, S/O - Lt.
