Sir,

I do here by lodged written complaint against 1) Bishnupada Garai S/o-Nishakar Garai 2) Sudam Garai S/o-Lt. Bhuthnath Garai 3) Dasharath Bisui S/o-Amulya Bisui 4) Suresh Duley S/o-Mihir Duley 5) Chaitan Bisui @ AdityaS/o-Paban Bisui 6) Uttam Duley S/o-Lt. Charan Duley all of Sukhadali, P.S-Sarenga, Dist-Bankura.

To the effect that today (26.09.18) BJP called 12 hrs Bangla Bandh. During duty myself found at Sukhadali more around 09:00 hrs the above noted persons and 40 -50 others BJP supporters blocked at Sukhadali more on P. More - Sarenga road they have Lathi, Ballam, Tangi, Bow and Arrows. They blocked the road under leader of Bishnupada Garai. On seeing the Police they started shouting "Slogans". I approached and requested them to remove the road block but they did not pay any heed to me and continued the block. Then I declared their gathering as unlawful assembly and requested them to disperse instantly but they continued the block. Having found no alternative myself along with force tried to remove the unlawful assembly from the road to movement of vehicle, but the miscreants obstructed us to discharge our official duty. At last around 11:00 hrs we succeeded to remove the road block.

Thus the above noted miscreants have committed an offence u/s-143/148/149/186/353/506 IPC.

So I requested you a specific case against 1) Bishnupada Garai S/o-Nishakar Garai 2) Sudam Garai S/o-Lt. Bhuthnath Garai 3) Dasharath Bisui S/o-Amulya Bisui 4) Suresh Duley S/o-Mihir Duley 5) Chaitan Bisui @ AdityaS/o-Paban Bisui 6) Uttam Duley S/o-Lt. Charan Duley all of Sukhadali, P.S-Sarenga, Dist-Bankura and 40-50 members and supporters BJP of Sarenga Block may kindly be started u/s-143/148/149/186/353/506 IPC and arrange its investigation.
