Sub:- Complaint.

Sir,

I beg to report that on 24.12.18 at 11.45 hrs received a source information over telephone that one person with one Tata pick-up 407 DI vehicle bearing Reg. No. WB-67A/0591 loaded with illegal coal is standing at Dhaldanga more near Ashirbad Hotel under Bankura PS. After getting such information I inform the matter to I/C Bankura PS over telephone and being directed by I/C Bankura PS myself along with force C/962-Somdutta Singh Patar, C/1028-Sanjoy Singh, C/567- Sunil Das vide CC. No. 3137 dt. 24.12.18 & GDE No. 1319 dt. 24.12.18 had been to the above mentioned place and I found one vehicle bearing Reg. No. WB-67A/0591 standing at Dhaldanga more near Ashirbad Hotel with loaded coal approx 02 MT. On search found the driver of said vehicle fled away. I search the surrounding area at Dhaldanga more but could not appear any driver or owner with valid documents of vehicle and loaded coal. It could be presumed that the aforesaid coal is stolen and carrying fraudulently. Hence it is evident that, the above noted coal was procured by the driver of the said vehicle with the connivance of it's register owner and others either by theft or by any fraudulent means. So, I having no other alternative I seized the vehicle bearing Reg. No. WB-67A/0591, loaded with coal approx 02 MT. under preparing proper seizure list duly signed by the witnesses.

Hence, I pray a specific case under proper section of law may kindly be started against the register owner, driver of vehicle bearing No. WB-67A/0591 and others for violation of existing law of the land.
