I, Joydeep Halder S/O Bimal Chandra Halder, A.E & Station Manager, Bishnupur Customer Care Centre, WBSEDCL being empowered by Electricity ACT 2003 ammended in 2007 do hereby lodge a complaint against accused Basudeb Mahanta S/O Niranjana Mahanta Vill-Hetagora Paschimpara (beside NH60) , P.o-Bankadaha to the effect that received an information that the said accused persons are committing theft of electricity by tampering energy meter of WBSEDCL illegally and after opening the meter it is found that CT circuit was bypassed by adding three green coloured resistance. So meter recorded less energy for commercial purpose.

On getting the information of theft of electricity I along with Sri Kaushik Akhuli S/O Sri Doyamoy Akhuli , SAE Bishnupur CCC, Sri Haradhan Chatait, Hr Gr. Sr. LM s/o Late Amar Chatait and other technical staffs of Bishnupur CCC on dated 28/12/2018 between 12:30 to 1:00 pm inspected the Hotel of Basudeb Mahanta ,S/O: Niranjana Mahanta Vill-Hetagora(beside NH-60) , P.o-Bankadaha P.S : Bishnupur Dist : Bankura.

During inspection it was detected that the said accused persons were committing theft of electricity by tampering energy meter of WBSEDCL illegally and after opening the meter it is found that CT circuit was bypassed by three numbers of resistance. So meter recorded less energy for commercial purpose It was found that connected load was: 1.5kw pump r ()

I prepared inspection report on the spot and assessed consumption of load which was detected as 2.5kw . The details I have mentioned in inspection report.

I directed Sri Hradhan Chatait S/O Late Amar Chatait to Dennergised the meter which was connected to LT over head line of WBSEDCL. Accordingly he disconnected the cable and I seized the same and prepared the seizure list in presence of accused.

Copy of seizure list and inspection report has been prepared in the presence of accused and accused put signature on inspection report, seizure list and seized item label. It is well proved that accused Basudeb Mahanta S/O Niranjana Mahanta Vill-Hetagora (beside NH 60) , P.o-Bankadaha P.S: Bishnupur Dist: Bankura is involved in the case of theft of electricity. Please lodge the complaint as F.I.R.
