Sir,

I, Sri Paritosh Kumar Baidya S/O-Lt. Amulya Kumar Baidya, Station Manager Hirbandh C.C.C, WBSEDCL being authorized under the electricity Act, 2003 and electricity (Amendment) Act, 2007 do here by lodge complaint against Gopen Pal S/O. Lt. Gopal Ch. Pal address, Vill- Tilaboni (Near PHE Water Tank), P.O- Bouridiha, P.S- Hirbandh, Dist-Bankura (Actual Address- Vil- Phulkotala, P.O.- Sikarpur, P.S.- Murutia, Dist- Nadia) for theft of electricity u/s- 135(1)(a) of the electricity Act, 2003 and electricity (Amendment) Act, 2007 as stated here under :-

That on 24.12.2018 in between 13:25 Hrs. and 13:45 Hrs. myself along with (1), Suryeswar Sen (S.E. S & LP), Bankura Region, WBSEDCL, S/O- Lt Guruprasad Sen (2) Subodh Ch. Patra (H.G Sr. L.M.) Hirbandh CCC S/O- Lt Nirmal Ch. Patra, (3) Srijib Sinha (Hg. Sr. L.M.) Hirbandh CCC S/O Lt Radheshyam Sinha, and others inspected the **commercial** premises (Tent) of Gopen Pal S/O. Lt. Gopal Ch. Pal for manufacturing of well ring with address as noted above on the basis of secret source information.

During inspection and checking Gopen Pal S/O. Lt. Gopal Ch. Pal was using electricity unauthorized and dishonestly by direct hooking from the nearby L T Mains of WBSEDCL with the help of hooking device and 2 core flexible wire causing huge revenue loss to WBSEDCL. During inspection said Gopen Pal S/O. Lt. Gopal Ch. Pal was present on the spot and signed on inspection report and seizure list also.

Thus it is evident that said against Gopen Pal S/O. Lt. Gopal Ch. Pal address, Vill- Tilaboni (Near PHE Water Tank), P.O- Bouridiha, P.S- Hirbandh, Dist-Bankura (Actual Address- Vil- Phulkotala, P.O.- Sikarpur, P.S.- Murutia, Dist- Nadia) has committed theft of electricity by direct hooking from nearby LT mains of WBSEDCL and liable for prosecution u/s 135(1)(a) of the electricity Act, 2003 and Electricity Amended Act 2007.

I prepared the inspection report and assessed the load which came to 100 Watt on the spot.


The unauthorized hooking line was disconnected as per provision of law & I seized the same by preparing seizure list.

Local witnesses refused to sign on the inspection report and seizure list.

There were other items of electrical appliances which could not be removed and sized at the time of raid. The raiding party left the site at 13:46 Hrs. on same day (24.12.2018) after completion of inspection and checking.

So, you are requested to treat this written complain as FIR, Start a case, arrest the accused and arrange investigation.




