Sir, With due respect our humble submission I beg
to draw your kind attention to the following that
I am Nilanjana Mistriy Das, (Sl.no - Shyamal Das),
W/o - Prof. Hiranmay Mistriy, Vill + P.O + P.S - Endfuru,
Dist - Bankura, PIN - 722136. I met Jitab. Hiranmay
Mistriy, Sl.o - Mr. Sukumar Mistriy, Vill + P.O - Chhoto Gehar
P.S - Sandeshkhali, Dist - North 24 Parganas, W.B - 74342
He is a professor of Ramkrishna Mahata government
Engineering college (Purulia government engineering col.
of electronics and communication engineering department
As I took admission there in 2017 in computer
Science Engineering department I met with him. Then
we became friends in Facebook. gradually the
relationship changed from student teacher to girl's
boyfriend. He had married me on 15th March, 2018 in
Bhederabol, under P.S 'Sekhet' (which is well known as
Hindu Vinayak by 'Gandharvamata'). Every thing
was okay upto July, 2018, we have dated for three
times. On a day while we met at Bhederabol under
under P.S in an open field he made me half-nude
and touched my breasts, waist, vaginal space, kiss
on all over my body, he had done oral sex with
me and forced me for having sex with him, he
forced me to masturbate him and he did fingering
in my vaginal space without my intentions by seducing

He has blackmailed me emotionally again and again to give him nude pictures of mine through whatsaap. As he is my husband I gave him \$0. He has harassed me physically & mentally by using this ways. He has assaulted me and molested me by giving fake promises like he will marry me legally (court marriage) very soon. Suddenly in July, 2018 he did break up with me without any valid reason & stopped all communications with me. While during relationship he used to talk to me over mobile phone for hours and also in whatsaap. As I told him to accept me publicly he refused everything and threatened me that he will post my nude pictures on social media & by making fake facebook account he did the same in October. He is also giving me badnames publicly. Now he is trying to marry another girl after spoiling me. He has cheated with me. He didn't tell me about his previous marriage which was divorced. As I am telling him to marry me legally and accept me publicly he is denying every thing & giving me threatenings too. His elder brother Mr. Pulak Mistry has sent me threatening text. He has also abused me very badly by using vulgar slangs like 'Rendy', 'Prostitute', 'Tomboy', 'Women of Jonagadhhi'... etc. which are too much unadmirable and intolerable. Hiranyak Mistry and Pulak Mistry are more harassing me mentally by giving threatenings. They are humiliating me publicly and defaming me everywhere in front of everyone. They are lessening insults to me and my family & are telling lies to hide all the truths. I have attempted suicide several times for all these. If anything bad happens to me Hiranyak Mistry along with all his family members and relatives will be responsible for that.

I am too much disturbed by them as they forced me during my Semester examination. WhatsApp chats, call recordings, call history and messages are with me in support of my statements.

Therefore, I am requesting you with folded arms to please take drastic steps against Hiranmay Misra and Pulak Misra as soon as possible. Please take heavy steps for me so that he accepts me publicly as his wife and marry me legally. Please look into the matter so that he can hardly spoil anyone's life any more as he has broken me down totally.
