It is submitted that our vehicle reg. No UP-32-B4-0674 of this unit while returning from Khatra, Distt. – Bankura met with an accident at 12 mile jungle State Highway-2 at about 8 kms from Raniband towards Jhilimili U/PS Raniband, District Bankura at about 1330 hrs on 24/12/2018 due to rash and negligent driving of vehicle No. WB-41-F-0407 (Dumper) by his driver. The said Dumper was coming from Jhilimili side & was moving towards Raniband collided with our vehicle from front in which following 05 personnel of this unit including driver are injured severely besides extensive damage of our said vehicle. All personnel evacuated to Govt. Primary Health Centre at Ranibandh immediately for treatment and after giving first aid, all of them referred to Bankura Medical Hospital for further treatment.
