I, Sri Uttam Kumar Das s/o Sri Indranarayan Das, AE & SM, Sonamukhi CCC, Sonamukhi, Bankura being empowered by Electricity Act 2003 Amended in 2007 hereby want to lodge complaint against Avijit Sikdar s/o Lt. Nilkamal Sikdar of Village: Kenety, PS: Sonamukhi, Dist: Bankura to the effect that received on information on that the accused was committing theft of electricity by direct hooking with single core PVC Cable by two numbers of length about 28 Feet each to supply electricity to his residential premises for domestic purpose.

On getting information from reliable source of electricity theft by the accused person cited above, today i.e. 27.12.2018 at around from 14:30 hours to 15:00 hours, along with Sri Hare Krishna Sau, OE s/o Lt. Subal Chandra Sau and Sri Chandradeb Khetrapal, Hg. TSH s/o Lt Benu Pada Khetrapal both of Sonamukhi CCC inspected the spot of the accused located at Village: Kenety, PS: Sonamukhi, Dist: Bankura.

During the inspection, it was detected that the accused Avijit Sikdar was enjoying electricity unauthorized by direct hooking with single core PVC cable by two numbers in length about 28 feet each from the nearest LT Overhead Line to supply electricity to his residential premises.

I prepared inspection report of the accused person at the spot and assessed the consumption load. Consumption load of the accused person was detected as observed load of 0.6 K.W. Details regarding of illegal consumption as cited herewith, I have mentioned it in inspection report attached with it.

I directed Sri Chandradeb Khetrapal to dehook the said PVC cables that were used to supply electricity to his residential premises for Domestic purpose from the nearest LT Overhead Line. The Cable used for direct hooking was seized and seizure list was prepared on the spot.

Copy of inspection report and Seizure List prepared at the spot could not be handed over the accused for his absence and to his representatives for their unwillingness to take it.

It is well proved that the accused person committed theft of electricity by single core PVC cables by two numbers for direct hooking from the nearest LT Overhead line to provide electricity to his residential premises for Domestic Purpose.

As such, he is liable for prosecution U/S 135 (i) (a) Electricity Act 2003 Amended in 2007.

Kindly treat this complaint as an FIR from your end.
